

In an effort to provide uniformity and consistency between the offices of the Chapter 13 Trustees in the Southern District of Ohio, Eastern Division, Trustee Bailey is transitioning all docketing information from the present docketing website to the Matter Calendar found at 13network.com. In order to give attorneys an opportunity to familiarize themselves with the matter calendar process, case information for the May 2021 dockets can be found on both the docketing website and the Matter Calendar. However, beginning in June, use of the docketing website will be discontinued, and all information will be available only on 13network.com. We have provided step-by-step directions below regarding the matter calendar process:

1. Please log into your 13 Network account at <https://www.13network.com/LoginMain.aspx?tc=wor>. If you do not have a 13Network account **with our office**, please complete the web agreement at <https://www.ch13.org/webaccessagreement.php>
2. At the top right-hand side of the first screen, click on the “Matter Calendar” link (highlighted in yellow).
